DIVISION CHANGE **A \$50.00 division change fee** will be requested upon check-in for the following:

1. Athlete not registered for proper belt, division, events, etc.
2. Athlete not registered for proper weight class.
3. Athlete does not make weight upon first attempt and wants to change division to avoid disqualification from tournament.

We appreciate all our coaches for supporting your athletes in our event. **Please help make our event run smoothly** by confirming that your students are registered in their correct divisions, weight class, and events.

COACH REGISTRATION

Steps for Being a USAT Coach for the 2025 USA Taekwondo Connecticut State Championships:

1. Coaches are required to hold AC Certification to register as a COACH. Register for the associate coach quiz online and pass the online exam to register as a coach. Coaches can register online at www.usataekwondo.sport80.com
2. Upon passing AC quiz, register as a coach for the 2025 USAT Connecticut State Championships.
3. All registration must be listed as CONFIRMED in order for you to coach. Please clear documents with **USAT office** by sending in all necessary documents seen in the check box for the 2025 USAT Connecticut State Championships.
4. **Coaches fees must be made online.** Payments will not be accepted at the door.
5. Coach pass can be picked up on Saturday, April 12 at Newtown Youth Academy. Only CONFIRMED coaches can pick up credentials. We will not clear any PENDING documents for coaches or athletes Saturday morning. Coaches listed as PENDING must clear all documents with USAT two (2) weeks prior to registration deadline. We do not print your ID card on the spot when you check-in so please make sure to notify us early.

All officials and referees of the championship, upon their discretion, hold the right to take away your coach pass and expel you from the competition floor for general misconduct and poor sportsmanship. Additionally, any coach that does not adhere to the USAT Code of Conduct will be reported to USAT immediately. Please show good Taekwondo spirit, sportsmanship, and respect towards one another.

GENERAL INFORMATION – PART II

- PENDING Any pending athletes must clear their documents as **CONFIRMED** in order to receive their credentials. **No athletes or coaches will receive credentials if they are PENDING.** Please register and clear early. Poomsae and breaking divisions **DO NOT** weigh in and can just pick up credentials on April 12th. (Check USAT SPORT80 site to see status)
- POOMSAE Designated Poomsae
Color Belts:
 - Yellow – Taeguk 1 or 2
 - Green – Taeguk 3 or 4
 - Blue – Taeguk 5 or 6
 - Red – Taeguk 7 or 8Black Belts:
Designated poomsae will be announced two (2) weeks prior to the competition on the CSTA website.
Electronic PoomsaePro scoring system will be in use.
- BOARD BREAKING All board breaking competitors **MUST** prepare their own boards. Boards may be purchased on site. Any tampering of the boards will result in immediate disqualification. Competitors must have their own board holders; no spacers. **Chairs Allowed.** Maximum boards: 15 (for *color belt* divisions); 20 (for *black belt* divisions). Board Size: 3/8-inch-thick; 10-inch-wide (one size for all ages). Time Limit: 2 Minutes. Two Attempts: (1) -0.1 pts; (2) -0.5 pts. Out of Bounds: -0.5 pts. **\$3 per board**
- SPARRING All Sparring Divisions will follow the Current USAT Rules. Electronic Daedo scoring system will be in use. Please note, all world class 12 years and older competitors have to bring Daedo Gen 2 socks. **You must purchase socks PRIOR to the tournament, socks will NOT be available for sale at the tournament site.**
- WEIGH-IN April 11, 2025 @ 152 Amity Road, New Haven, CT 0652 in two waves:
 - Wave 1: 1PM - 4PM
 - Wave 2: 6PM - 8PMAll sparring athletes must attend weigh-in (mandatory). Any athlete that does not make weight after the 2nd attempt will be disqualified. Any athlete who needs to change division after the 1st attempt may change division with \$50 change division fee. All out of state athletes, along with athletes with nobody listed in their division must weigh in. Failure to report when athlete is called to the ring will result in **DISQUALIFICATION**.
- AWARDS Medals will be awards to the top four (4) athletes in each division. 1st (Gold), 2nd (Silver), 3rd (Bronze), and 4th (Bronze).
- UNIFORM Color Belts: White Uniform Only (*All Color Belts and Demo Team*)
Black Belts: Black V-Neck White Uniform Only
Poomsae Athletes: Y-Neck Poomsae Uniforms Allowed (*Black Belts Only*)
No Colored Uniforms will be allowed with the exception of WTF Poomsae Uniforms.
